## **DECLARATION**

In consideration of the Organizers accepting an application by the Driver/Competitor whose name appears below for entry to an Event or the Series, the Driver/Competitor acknowledges, represents and undertakes to the Promoter and the Organizers as follows.

- 1. (*Regulations*) The Driver/Competitor's participation in the Series or an Event is subject to the Driver/Competitor complying with the Regulations. The Driver/Competitor has read the Regulations and will not breach any provision of the Regulations.
- 2. (**Standard**) Having regard to the Circuit and the speed vehicles will attain in a Race, the Driver has the necessary skills to participate in an Event and the Series and any car used by him or her will be suitable and roadworthy for each Race.
- 3. (Risk) The Driver acknowledges that motor racing is a dangerous sport and the Driver has voluntarily assumed all risks associated with participation in each Event including the risk of Loss to himself/herself or to other persons.
- 4. (No Liability) The Driver/Competitor agrees that each Indemnified Person shall have no liability to him or her in contract, tort or otherwise including liability for negligence arising by reason of or in connection with the entry, participation or failure to participate of him or her in an Event or the Series. This paragraph does not apply to liability with respect to death or personal injury.
- 5. (**Death or personal injury**) The Driver/Competitor agrees that each Indemnified Person shall have no liability to him or her (but only to the extent permitted by law) for any death or personal injury arising by reason of or in connection with the entry, participation or failure to participate by him or her in an Event or the Series.
- 6. (Indemnity) The Driver/Competitor indemnifies each Indemnified Person and will keep each of them indemnified against all Loss arising in any way out of his entry, participation or failure to participate in an Event or the Series.
- 7. (Sums) The Driver/Competitor will pay all entry fees requested in any entry form for an Event or the Series and will pay as liquidated damages for breach of the Regulations any sum (including any fine or penalty) awarded against him or her in accordance with the Regulations.
- 8. (Consents) The Driver/Competitor grants to the Promoter and the Organizers all consents, licenses and approvals and makes all assignments required by the Regulations.
- 9. (Terms) Terms defined in the Regulations shall apply in this declaration unless the context requires otherwise. Indemnified Person means the Promoter, the Organizers, each Circuit owner or manager, each Manufacturer, Entrant or other Driver and each of their respective employees, agents, officials and contractors. Loss includes liability, cost, damage, expense, fee or charge in respect of any property or person and death or injury to any person.
- 10. (Severance) Should any term or condition in this declaration be prohibited or unenforceable in any jurisdiction, that term or condition will be ineffective as to that jurisdiction to the extent of the prohibition or unenforceability. That shall not affect the validity or enforceability of that term or condition in any other jurisdiction or the validity or enforceability of any other term or condition.
- 11. (Law) The Regulations and this declaration are governed by the laws of Thailand and all disputes, controversies or claims arising out of or in connection with any document, including the breach, termination or invalidity thereof, shall be finally settled under the laws of Thailand.
- 12. (Confidential matters) Sharing confidential information obtained in confidence through interactions with the Promoter and the Organizers is strictly forbidden.
- 13. (Consent) Unlawfully taking images and sharing content on Social Media without obtaining necessary consents. It is each person's responsibility to ensure all necessary consents as requires at law from individuals is provided before sharing any images, text, recordings, etc. of a person. Situations where extra vigilance should be used include:
  - (a) Sharing recordings or images where an event is also being broadcast which places a person in breach of the licencing agreements in place.
  - (b) Using trademarks and other people's material over which they have copyright.
